

**MINUTES OF MEETING
CITY COUNCIL OF THE
CITY OF LAKE BUENA VISTA
September 28, 2020
5:35 P.M.**

A regular meeting of the City Council of Lake Buena Vista was called to order on Monday, September 28, 2020 at 5:37 P.M., at 1900 Hotel Plaza Boulevard, Lake Buena Vista, Florida.

Those present were Mayor Renee Raper, Council Members, Tom Nedorost and via phone, Angie Sola constituting a Quorum. Others present were Tina Graham, City Clerk; Susan Higginbotham, City Auditor; John Classe, City Manager of Bay Lake; Chris Quinn, RCID Finance Manager; via phone, Ann Blakeslee, City Manager; and Mike Crikis, Assistant City Manager.

The Clerk presented proof of publication of the meeting notice. **(Exhibit A)**

A motion for approval of the Minutes of the September 14, 2020 meeting was made by Tom Nedorost and duly seconded by Angie Sola. The minutes were approved as presented.

Ms. Higginbotham, City Auditor presented a budget amendment for FY20 to the Council for \$50,000. The \$50,000 represents an overage in the Public Safety Expenditures which will be offset by additional revenue collected in lieu of taxes for \$50,000. The budget amendment has a zero effect on the FY20 ending budget balance. A motion was made by Tom Nedorost, duly seconded by Angie Sola, and approved by all attending Council members. **(Exhibit B)**

The Public Hearing portion of the meeting was called to order at 5:39 P.M. and the City Auditor Susan Higginbotham presented Council with the budget and millage rate for Fiscal Year 2021. Ms. Higginbotham stated that the budget presented remained the same as the tentative budget information approved at the September 14th meeting. The millage rate will be 1.5915. Following the Auditor's presentation was a question and answer session. Public Hearing portion of the meeting was closed. **(Exhibit C)**

A motion for approval of Resolution No. 175, adoption of a millage rate of 1.5915 dollars per one thousand dollars of assessed value for FY 2021, which is (0.00% more) than the rolled-back rate of 1.5915 computed pursuant to Florida Statutes 200.065 was made by Tom Nedorost, duly seconded by Angie Sola, and approved by all attending Council members.

RESOLUTION NO. 175

WHEREAS, the City of Lake Buena Vista intends to levy a millage rate of 1.5915 dollars per one-thousand dollars of assessed valuation; and

WHEREAS, Section 200.065, Florida Statutes requires that a resolution levying a millage rate be approved by the taxing authority; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation has been certified by the County Property Appraiser to the City of Lake Buena Vista as \$2,885,023,937; and

WHEREAS, the City of Lake Buena Vista has, in accordance with Section 200.065 Florida Statutes,

1. Held a public hearing on September 14, 2020 for the purpose of adopting a tentative millage rate and budget, and
2. Advertised its intent to finally adopt a millage rate and budget; and
3. Held a public hearing on September 28, 2020 for the purpose of receiving comments regarding the final millage rate.

NOW, THEREFORE BE IT RESOLVED, that the City of Lake Buena Vista, through its City Council, hereby levies an operating millage rate of 1.5915 dollars per one thousand dollars of assessed value for FY 2021, which is the same as (0.00% more) than the rolled-back rate of 1.5915 computed pursuant to Florida Statutes 200.065; and

BE IT FURTHER RESOLVED by the City Council of the City of Lake Buena Vista assembled in regular session this 28th day of September 2020 that this Resolution be spread in full upon the minutes of this meeting.

A motion for approval of Resolution No. 176 for FY 2021 budget on its final reading was made by Tom Nedorost, duly seconded by Angie Sola, and approved by all attending Council members.

RESOLUTION NO. 176

WHEREAS, the City of Lake Buena Vista intends to adopt a budget; and

WHEREAS, Section 200.065, Florida Statutes requires that a resolution adopting a budget be approved by the taxing authority; and

WHEREAS, the City of Lake Buena Vista set forth the appropriations and revenue estimate for the Budget of Fiscal Year 2021 in the amount of \$7,044,168; and

WHEREAS, the City of Lake Buena Vista has, in accordance with Section 200.065 Florida Statutes,

1. Held a public hearing on September 14, 2020 for the purpose of adopting a tentative millage rate and budget, and
2. Advertised its intent to finally adopt a millage rate and budget; and
3. Held a public hearing on September 28, 2020 for the purpose of receiving comments regarding the final millage rate and budget; and

NOW, THEREFORE BE IT RESOLVED, that the City of Lake Buena Vista, through its City Council, hereby adopts a budget for the FY 2021.

BE IT FURTHER RESOLVED by the City Council of the City of Lake Buena Vista assembled in regular session this 28th day of September 2020 that this Resolution be spread in full upon the minutes of this meeting.

There being no further business to come before the Council, Tom Nedorost made a motion to adjourn the meeting; it being duly seconded by Angie Sola, the meeting was adjourned.
