SWIMMING POOL PROGRAM AND PERMIT REQUIREMENTS

Following is a summary of requirements for swimming pool permit applications applied within the Reedy Creek Improvement District (the District).

SWIMMING POOL CONSTRUCTION REQUIREMENTS

- All swimming pool permits (regardless of the work) will require **both** the District's standard "Application for Permit" **and** the District's "Application for Swimming Pool Construction Permit" applications. The standard permit application must be completed in full and signed and notarized by the contractor and the owner. The swimming pool application must be completed in full and signed and sealed by an engineer.
- 2) In addition to the District required applications for new pool construction, a State of Florida Department of Health "Application for a Swimming Pool Operating Permit" (form DH 4159, effective 9/2015) must be completed and submitted to the District prior to the issuance of the Initial Operating Permit. The form can be found on the State website at: <u>http://www.floridahealth.gov/environmental-health/swimming-pools/index.html</u> under the "Forms" tab. An initial operating fee of \$350 is due prior to certification. Note: if the initial operating permit is submitted prior to the end of construction, a revised application may be required, based on changes made from the initial submission.
- 3) At the time of permit application, a complete set of submittals must also be submitted to the Walt Disney World Environmental Permitting Department. Submittals can be sent via email to: <u>wdw.environmental.permitting@disney.com</u>. For additional information, contact Environmental Permitting via telephone at: (407) 390-5215.
- 4) Architects will be allowed to sign the swimming pool application for non-engineering type of work (such as handrails and pool slopes). Anything structural in nature must be signed by an engineer (such as chairlift anchors). All drawings are required to be signed and sealed by either the engineer or architect (as appropriate).
- 5) Each pool or feature is considered as an individual unit, with a separate address, requiring a permit for each unit.
- 6) For resurfacing projects, drawings are not required. However, a detailed scope of work must be provided along with resurfacing material information, including installation instructions. Light levels will need to be retested to ensure life safety code requirements are met.
- 7) A certified licensed contractor is required to pull permits. See Licensing Requirements below.

CHART OF TYPE OF WORK REQUIRING A PERMIT

Following is a guideline on when a swimming pool permit might be required. Note: This is not a complete list and may be modified at any time. Check with the Building & Safety Department if you have any questions.

LICENSING REQUIREMENTS

A certified licensed "swimming pool" contractor must apply for most all work associated with a swimming pool, including equipment and piping, whereas a plumbing contractor may apply for swimming pool piping only.

Following is the definition of a swimming pool specialty contractor and class codes per the State of Florida Construction Industry Licensing Board (CILB):

SWIMMING POOL SPECIALTY CONTRACTOR

A "swimming pool specialty contractor" means a sub-contractor whose scope of work is limited to the scope of work of their particular specialty license. Swimming pool specialty contractor licenses may be issued in the areas of layout, structural, excavation, trim, decking, piping, and finishes. Swimming pool specialty contractors may not contract directly with the public, and must work under contract, under the supervision, and within the scope of work of a contractor licensed pursuant to *Sections* 489.105(3), Florida Statutes.

FLORIDA STATE LICENSE CLASS CODES AND QUALIFICATIONS PER THE CILB

CG and RG – A "general contractor" means a contractor whose services are unlimited as to the type of work which he or she may do. A general contractor shall not be required to subcontract structural swimming pool work. All other swimming pool work shall be subcontracted to an appropriately licensed certified or registered swimming pool contractor.

CP and RP – A "commercial pool/spa contractor" means a contractor whose scope of work involves, but is not limited to:

- the construction, repair, and servicing of any swimming pool, or hot tub or spa, including the repair or replacement of existing equipment or the installation of new equipment, as necessary;
- the layout, excavation, operation of construction pumps for dewatering purposes, steelwork, installation of light niches, construction of floors, guniting, fiberglassing, installation of tile and coping, installation of all perimeter and filter piping, installation of all filter equipment and chemical feeders of any type, plastering of the interior, construction of decks, construction of equipment rooms or housing for pool equipment, and installation of package pool heaters; and
- includes the scope of work of a swimming pool/spa servicing contractor.
- A "commercial pool/spa contractor" cannot perform direct connections to a sanitary sewer system or to potable water lines.
- The installation, construction, modification, or replacement of equipment permanently attached to and associated with the pool or spa for the purpose of water treatment or cleaning of the pool or spa requires licensure; however, the usage of such equipment for the purposes of water treatment or cleaning shall not require licensure unless the usage involves construction, modification, or replacement of such equipment.

CP and RP – A "residential pool/spa contractor" means a contractor whose scope of work involves, but is not limited to:

- the construction, repair, and servicing of any residential swimming pool or hot tub or spa including the repair or replacement of existing equipment or the installation of new equipment, as necessary;
- the layout, excavation, operation of construction pumps for dewatering purposes, steelwork, installation of light niches, construction of floors, guniting, fiberglassing, installation of tile and coping, installation of all perimeter and filter piping, installation of all filter equipment and chemical feeders of any type, plastering of the interior, construction of decks, installation of housing for pool equipment, and installation of package pool heaters; and
- includes the scope of work of a swimming pool/spa servicing contractor.
- A "residential pool/spa contractor" cannot perform direct connections to a sanitary sewer system or to potable water lines.
- The installation, construction, modification, or replacement of equipment permanently attached to and associated with the pool or spa for the purpose of water treatment or cleaning of the pool or spa requires licensure; however, the usage of such equipment for the purposes of water treatment or cleaning shall not require licensure unless the usage involves construction, modification, or replacement of such equipment.

CP and RP - A "swimming pool/spa servicing contractor" means a contractor whose scope of work involves the servicing and repair of any swimming pool or hot tub or spa. The scope of such work may include any necessary piping and repairs, replacement and repair of existing equipment, or installation of new additional equipment as necessary. The scope of such work includes:

- the reinstallation of tile and coping, repair and replacement of all piping, filter equipment, and chemical feeders of any type, replastering, reconstruction of decks, and reinstallation or addition of pool heaters;
- the installation, construction, modification, substantial or complete disassembly, or replacement of equipment permanently attached to and associated with the pool or spa for the purpose of water treatment or cleaning of the pool or spa requires licensure; and
- however, the usage of such equipment for the purposes of water treatment or cleaning shall not require licensure unless the usage involves construction, modification, substantial or complete disassembly, or replacement of such equipment.

CF and RF – A "plumbing contractor" means a contractor whose contracting business consists of the execution of contracts requiring the experience, financial means, knowledge, and skill to install, maintain, repair, alter, extend, or, when not prohibited by law, design plumbing. A plumbing contractor may install, maintain, repair, alter, extend, or design the following without obtaining any additional local regulatory license, certificate, or registration:

- sanitary drainage or storm drainage facilities;
- venting systems; public or private water supply systems;
- septic tanks; drainage and supply wells;
- <u>swimming pool piping;</u>
- irrigation systems; or
- solar heating water systems and all appurtenances, apparatus, or equipment used in connection with these, including boilers and pressure process piping and including the installation of water, natural gas, and storm and sanitary sewer lines; and water and sewer plants and substations;
- the design and installation, maintenance, repair, alteration, or extension of air-piping, vacuum line piping, oxygen line piping, nitrous oxide piping, and all related medical gas systems;
- fire line standpipes and fire sprinklers to the extent authorized by law; ink and chemical lines;
- fuel oil and gasoline piping and tank and pump installation, except bulk storage plants; and
- pneumatic control piping systems.

CM and RM – A "mechanical contractor" means a contractor whose services are unlimited in the execution of contracts requiring the experience, knowledge, and skill to install, maintain, repair, fabricate, alter, extend, or design central air-conditioning, refrigeration, heating, and ventilating systems, including duct work in connection with a complete system. A "mechanical contractor" <u>shall not perform work that involves</u> potable water lines or connections, sanitary sewer lines, <u>swimming pool piping and filters</u> or electrical power wiring.

ANNUAL SWIMMING POOL CERTIFICATION

All swimming pool certificates expire on June 30th. Certificate renewals are submitted to owners prior to the expiration date for fees due; along with verification of swimming pool / spa information and owner / address information. Once the renewal fee is received by the District's Building & Safety Department, along with any changes to the submitted information for verification, certificates are printed and submitted to the owner/operator. Renewal fee amounts can be found on the Building & Safety permit Fee Schedule. Included in the certification renewal process are quarterly operating permit inspections. The District conducts quarterly inspections with a minimum of two times per year, and a maximum of four times per year.

MAIN DRAIN CRATE/COVER RETROFIT

The Pool and Spa Main Drain Grate/Cover Retrofit Acknowledgement form is required for emergency and repair replacements and at the scheduled replacement cycle, based on the manufacturer's expiration date. The form must be completed in full and submitted to the District's Building & Safety Department and the Walt Disney World Environmental Permitting Department.
