I discussed with [REDACTED] a bit tonight. She contacted [REDACTED] and discussed at depth.

SOG Easement:

The land transfer from SOG to Disney has been agreed upon in concept and terms. Supposedly, the paperwork and easement, as drawn up by [REDACTED], is in the right people's hands to be signed. [REDACTED] explained that he will contact [REDACTED] to find out what the status is regarding ink to paper. Nobody has seen it and [REDACTED] has not been given anything official. [REDACTED] will contact [REDACTED] and update [REDACTED] and I in our meeting with him on Monday afternoon.

[REDACTED] mentioned that [REDACTED] and [REDACTED] were talking about the gas line that resides in that easement currently. [REDACTED] will remember that this was discussed in the page flip and related conversations. I can't remember what the final solution was, but [REDACTED] did have ideas. [REDACTED] is coordinating with him to find out if the solution will reside within that already drawn up easement or if it has to be just outside.

So looking at this, they give me the indication that the R/W has not be transferred into RCID property as of 8-23-22. I was under the impression from [REDACTED] that the ownership transfer has been completed, but these legal's state otherwise.

I am trying to get the TCE areas from P&E (this is all that they are willing to give me at this time), but it seems like that process is not completed for the area's outside of the future RCID R/W and the areas that would include the chiller plant work.

Let me send an email to P&E asking for just the TCE limits, outside of the future RCID R/W. I will include Ryan so he can have some fun with this....
