Thanks for the e-mail. We can discuss budget tomorrow. Are you attending the meeting? I think I just received a calendar notification that you declined.

I can also set up a 1-1 to get into more detail. I have asked for a summary of monthly costs todate as the basis for building next year's budget. Do you have this information to share and discuss? Broadly, budget and an agreed upon District priority should drive our work plan and execution. If requests are out-of-line with either budget or priority, I will carry this message to the building occupants.

Regarding large projects, **and** is aware that the District utility budget has placeholders and an approval process for anticipated and identified large projects. The SSA building A/C replacement will be funded using capital funds from the Facilities placeholder in the FY23 planned work budget.

We may also want to include District finance partners in a future discussion. There may be another preferred method to budget and capture costs for District facility maintenance related to utility operation.
